## **Step-by-Step Letting Process**

#### 1. Free Rental Valuation

We start by providing you with a no-obligation rental appraisal. We assess the market rate, your property's features, and the local demand to advise the best rent.

#### 2. Landlord Onboarding

To proceed, we'll ask for the following:

- Proof of ownership (Title deed or mortgage statement)
- Valid Photo ID and Proof of Address
- Landlord Bank Account Details (for rent transfers)
- Signed Terms of Business
- Consent from mortgage lender (if applicable)

#### 3. Legal Safety Requirements

Your property must meet legal safety standards:

- Gas Safety Certificate (CP12) if gas is present
- Electrical Installation Condition Report (EICR)
- Energy Performance Certificate (EPC)
- Smoke and carbon monoxide alarms fitted and tested
- Fire safety furnishings (if furnished)

#### 5. Tenant Referencing & Selection


We carry out full reference checks, including:

- Employment status/income
- Credit checks
- Previous landlord references
- Right to Rent checks (legal requirement)

#### 6. Tenancy Agreement & Deposit

Once approved, we:

- Draft a legally compliant AST (Assured Shorthold Tenancy)
- Collect the first month's rent and security deposit (held under a government-approved scheme such as DPS)
- Conduct a full inventory and schedule of condition (with photo/video backup)
